- To receive Cllrs Reports. Cllr Shelly: Letton Rd junction potholes. Also, Pothole 1237. outside cemetery still not repaired. A/P: Clerk to report to Highways. Tree overhanging in cemetery Cllr Crane will cut this back. Complaint about parking outside hairdresser parking on pavement. Cllr Fawcett advised nothing the PC can do. Clir Crane: Flood at opposite River Farm on Watton road, ditch blocked. A/P: Clir Playford: Car transporter parked on Clerk to report to Highways. Bradenham Rd. Cllr Fawcett reiterated that the PC cannot do anything about parking. Cllr Stolworthy: Have we got a hedge officer? Resident at Cushing Close - hedge now overgrown around the street light - needs cutting back. A/P: Clerk to write letter. Hedge at Parklands also needs cutting. Cllr Dewing declared an interest. Hedge is obstructing highway. A/P: Clerk to contact Paul Sellick to requested letter to householder. Rats on path a Fen Folgate. Rats between Parklands and Fen Folgate. Land owned by Ian Leonard. Cllr Aves: Also, received complaints about Rats at FF. Still some allotments to let 2 at DR and 7 at WR. Cllr Turner: Community Car Scheme has 4 volunteers, also being coordinated by volunteers. Bonfires reported on allotments but after investigation this was not the case, the bonfires were elsewhere. Parents delighted with new equip at park. Cllr Hewett: Notes for SN asap. Order signage for play equipment required and complete as part of the handover from HAGS. A/P: Cllr Hewett order signage and SN entries asap.
