1039. Clerk's Report – Received and noted as follows and decisions where required: The 2015/16 Internal Auditors report was received and noted. Cllr Playford thanked the Clerk for the work undertaken over the last seven months.

The Annual Return for 2015/16 was completed and signed by the Chair and Clerk. Memorial headstone noted and approved.

Quotation from TT Jones to replace 7 obsolete lanterns @ £285 each + vat

Proposed: Cllr Aves. Seconded: Cllr Secker. Unanimous. Quotation from J Larwood £250.00 Church path works. Proposed: Cllr Dewing. Seconded: Cllr Secker. Unanimous.

- 1040. PC Representation at Afternoon Tea celebrating HM QEII Birthday Cllr Fawcett. Decision required on PC contribution. Chair informed celebrations cost just under £500. Seek £250 or £200. Cllr Tuck reminded Cllrs that the application for funding was refused, the tea party element of the bid was considered poor, thus missing the opportunity to get £200 towards this event. Cllr Fawcett confirmed that the RBL did not decide until late in the day to host this event. Indeed, the Chair asked at the last meeting if the PC wish to be involved as a sponsor. Cllr Dewing suggested a 3 way split between RBL, Community Centre and SPC. Cllr Stolworthy Proposed: £170.00. Cllr Hewett proposed an amendment of £200.00. The amended proposal was seconded by Cllr Playford. FOR: 2. AGAINST 7. 1 ABSTENTION. Cllr Stolworthy's proposal of £170.00 was seconded by Cllr Dewing. FOR: 7. AGAINST: 1. 1 ABSTENTION. Motion carried.
- 1041. Footpaths and Bridleways Cllr Secker confirmed that this item had been sufficiently covered in PQs. **ACTION POINT:** Clerk to contact NCC to write to land owner again. Cllr Turner confirmed BDC contacted about footpath clearing at OSPF. Clerk also to write to Jill and Gordon Burrell to express thanks for the work carried out at the OSPF footpath. Cllr Fawcett expressed thanks also to Cllr Dewing for helping to clear the footpath.
- 1042. Defibrillator update on installation and training Cllr Tuck. Defibrillator is on the wall but is not yet in operation. Training will be arranged when appropriate. Coordinator for First Response has advised that the battery requires checking, and replacement pads and hygiene kit are required at intervals TBC. ACTION POINT: Clerk to erect laminated notice 'Not in Use' ASAP.
- 1043. Policies and Procedures Annual Review, update and adoption of P&Ps. Cllr Hewett reminded Cllrs that P&Ps are published on the village website. Cllr Hewett confirmed his review of the Financial Regulations which place no additional requirements on the PC as a whole and suggested that the following procedures should be adopted. 1. A Cllr other than the Chair should check the bank reconciliation on a quarterly basis. 2. A Debit or Credit card should be provided for the Clerk. 3. A 3 year budget plan should be prepared. Proposed: Cllr Hewett. Seconded: Cllr Turner. Motion to approve SO & Financial Regulations, Unanimous.
