#### MINUTES OF THE ANNUAL PARISH COUNCIL MEETING HELD 9 May 2016 IN THE WI HALL

Present: Councillors: Fawcett (Chair), Playford (Vice-Chair), Aves, Hewett, Dewing, Secker, Shelly, Stolworthy and Turner.

6 Parishioners in attendance.

- 1013. Election of Chairman (Clerk) including Declaration of Acceptance of Office and Business Interests. The Clerk opened the meeting and asked for nominations for Chairman. Cllr Fawcett volunteered to continue as Chairman unless any other Cllr wished to stand. No other nominations were made. Cllrs voted unanimously in favour of Cllr Fawcett as Chairman. Declarations of Acceptance of Office and Business Interest forms were signed by the Chair and witnessed by the Clerk. The Clerk handed over the newly elected Chairman.
- 1014. Election of Vice-Chairman (Chair) and declaration of Acceptance of Office and Business Interests. The Chair asked the current Vice-Chair Cllr Playford if she wished to express an interest in continuing as Vice-Chair and for any other nominations. Cllr Playford volunteered to continue as Vice-Chair. No other nominations were made. Cllrs voted unanimously in favour of Cllr Carole Playford as Vice-Chair. Declarations of Office and Business Interest forms were signed and witnessed by the Clerk.

1025. The Clerk's Report was received and noted with the following decisions made: Separate Accounts to be set up at Barclays to reflect earmarked reserves being held: Church Wall A/c £2,500. Street Light Replacement A/c £16,000 and WI Hall A/c £6500. These balances relate to contributions set aside from 2012 to 2016 budgets. See Clerk's Report Earmarked Balances.

Cllr Stolworthy asked the Clerk if there is anything Cllrs can do to help reduce overtime worked. The Clerk thanked Cllr Stolworthy and suggested a number of projects could be dealt with by Cllrs. The Clerk will bring list of suggestions to the next meetings.

<u>Cllr Fawcett</u>. Informed Cllrs that Shipdham Community Trust and the RBL are providing free afternoon tea on 12 June 2016 to celebrate HM Queen Elizabeth's 90<sup>th</sup> Birthday – all welcome. Cllr Fawcett asked if the PC wish to be represented at this village event. Cllr Hewett said that the PC should be represented and asked the Clerk to put this on the June Agenda to discuss any financial contribution the PC may wish to make to the event.

<u>Cllr Turner:</u> Bridleway complaint. Bridleway in question is subject to NCC Diversion Order. **Action point:** Clerk to inform parishioner.

<u>Cllr Secker:</u> Request for agenda item at June meeting. Footpaths information and OS maps will be presented for clarification. **Action Point:** Clerk to include on next agenda.

<u>Cllr Hewett:</u> Shipdham Drynkkings. – requested consideration of hiring Port-a-loos next year for this regular community event.

<u>Cllr Hewett:</u> Proposed that one of the parking signs should be placed facing the Old School development. Cllr Fawcett informed Cllrs that due to recent decisions on parking signs that this topic will not be included on the agenda for a period of six months.
