

- 1753. Local Plan Consultation Cllr Hewett gave an overview with regard to Shipdham points. 282 dwellings permitted 227 have been built or already have planning. Target 55 new homes within boundary of Shipdham. No real change for Shipdham in regard to plan.
- 1754. Toilet Facilities at Drynkkings approve costs up to £200.00 for facilities. Proposed: Cllr Turner Seconded: Cllr Hewett
- 1755. Appoint Internal Auditor SCS Accounting- awaiting to hear.
- 1756. To discuss S106 Monies Cllr Turner Short on time. Judo have asked for £3000 towards mats. Teen shelter at Bullock Park discussion took place. Cllr Aves suggested tennis court on land beside bowling green or multipurpose usage, approx. cost £40,000.00. Match funding for multipurpose MUGA maintenance, access and other issues.
