Cllr Hewett explained timeline: in 2017 planning permission granted included garage. Variations since then kept the application live. In 2019 new application which removed the garage was turned down – a decision subsequently maintained on appeal. However, the Landlord had given notice to tenant to vacate the premises, meaning the garage is closing. This is a personal dispute between the two parties, and the Council has no influence on the outcome.
