


SHIPDHAM PARISH COUNCIL

- 1933. To discuss whether Shipdham village becomes a No Cold Calling area deferred to November when quotes in. Cllr Turner and Co-ordinator to work together.
- 1934. To discuss village 30mph sign Restrictions on where signs can be placed but still valuable asset to village. Proposed to replace batteries and brackets needed: Cllr Hewett Seconded: Cllr Shelley. SPC to thank P Chubbock for his works.

- 1936. To discuss and grant permission for alterations to Churchyard Wall SPC does not own the Church wall and PCC will need to grant permission. SPC can give view with regard to health & safety concerns. Proposal in favour of alterations in principle in order to increase highway safety Cllr Crane, Cllr Allum, Cllr Hewett, Against: Cllr Dewing, Cllr Stolworthy, Cllr Shelley. In the case of equality of votes Cllr Hewett gave casting vote in favour, as acting Chair in accordance with SO 3(q).

Allotment meeting – everyone happy with rentals. Hedge between Watton Road Allotments & dusty meadow needs cutting. AP Clerk to ask John Larwood to cut. Community allotments raised – AP Cllr Hewett to advertise for co-ordinator and interest. Parish Council would pay rental for plot at either end and to purchase some tools. AP Cllr Shelley & Cllr Stolworthy to oversee.

Hedges at Parklands & The Bothy, Chapel Street. AP Cllr Stolworthy to get building numbers for Clerk to write.

Cllr Dewing – Ditch at Dereham Road allotments is full of debris AP Clerk to contact Z Nock to clear ditch. TTSR cutting close to Church and causing damage. AP Clerk to contact TTSR. Damaged section of Church window to be repaired AP Clerk. Dog fouling Bradenham Road – all to get name of certain dog owner.

Cllr Allum – Sweet papers on Pound Green Lane from children. AP Cllr Hewett to mention in Shipdham News.

BDC A decision by Cabinet has been published: VE/VJ Day 75th Anniversary Celebrations 2020. Decision: Grant for a £30,000 VE and VJ Day celebratory grant scheme for community events to commemorate the 75th Anniversary of the end of World War II; the 80th Anniversary of Dunkirk and Battle of Britain, in 2020 be approved, and be administered by the Norfolk Community Foundation (NCF) – noted.
