Trapp Lane proposed planning. Parishioner raised the following points. - agricultural land and cannot be developed.

1. That he had (along with other neighbours) been offered a piece of the land as an extension to their gardens previously. 2. That the 7-acre site currently falls outside the envelope of the village. Furthermore, after the proposed 4/5 properties were built what would become of the rest of the site. 3. That when the land was offered previously for sale that it was quoted as being prime agricultural land. A point that along with being outside the village envelope meant it should not be available for development, and that the housing quota for the village was already being met by existing development plans. 4. That the carpark would not be able to be lit at night due to no power being available and doubt that it would get used that much. 5. As the lane is unsurfaced at that end and there had already been an incident with a householder being injured by a car then improving the surface would only contribute to the speed at which vehicles would be able to travel. Comments were noted.

Pot hole in Little Hale Road outside Mill Farm AP Clerk to report.


