Cllr Worth – Thanked Council for course which was very informative. County Council has questioned to toxicity and carcinogenic properties of round up. Cllr Crane said there was no factual evidence and no alternative to use. Noted AP Clerk to contact contractor to see if it is used.

Cllr Smith - Thanked Council for course.

Cllr Shelley – Health & Safety issue regarding cobbles in layby parking at Pound Green Close AP Clerk to raise to Highways.

Cllr Woodrow – Townshend Place/Mill Road junction see to the right – commented that owner regularly cuts hedge. Cemetery path is full of weeds AP Clerk to chase contractor. Clayland developments re Swan Lane, hedge will need to be moved and lamp post. Wait to Clayland to request permission to move lamp post.

Cllr Allum – Footpath from Pound Green Close to Park Highatt Drive overgrown. AP Chase contractor and send letters to Parishioners and report to Rangers.

Cllr Stolworthy – Parklands number 25/27 driving over the grass to park in front of houses. AP Clerk to write letter.

Cllr Playford – Parklands Avenue footpath (rear of number 14), hedges overhanging so not passable if on horseback AP Clerk to submit to Rangers. Gazeboes advertising for hire in Parish magazine.
