Prior to meeting, Clayland Homes will be doing a short presentation regarding planning application.

Clayland Homes presented their application for Pound Green Lane. Parishioners raised questions regarding access, especially during school drop off/pick up points, also the traffic from plant machinery. Condition built in for times of site traffic movement. Concerns raised regarding visibility at access point. Concerns also that the development is bordering the village boundary.

Swan Lane development, Cllr Crane declared interest and withdrew from meeting. Observations as to planning meeting re permissive footpath. Expressed view to say you were happy to move the footpath, not enough ownership on Swan Lane to put footpath in. Pinch point at the flint wall. Parishioners want to get rid of the propose Permissive footpath totally. Risks regarding flooding of land.

Mr Thompsons agreement to return the road to good state of repair. Drainage onto the road AP to get quotes
- 1610. To pledge monies to underwrite the Church window permission to put window in. DAC needed funding of 80% or more. Cemetery cutting hedge on right hand side. AP Clerk to contact TTSR Gentleman who owns allotment sold vegetables outside Cllr Secker's property and gave monies raised to charity. Grass at church yard looks good.
